



Official Rules, Terms, and Conditions

Enter by Code: Scan the code on the Mountain DEW display materials in participating Cub Foods retailer stores in Minnesota to enter from your mobile device (“Mobile Device”). By scanning the Code with your Mobile Device, you will be taken to the URL dewmoafun.com and guided to follow the on-screen instructions to submit an entry. Data rates may apply if participating via a Mobile Device. Check with your wireless service provider for details on any applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers may participate.

ENTRY OPTION 2:

Enter Online: Visit dewmoafun.com and follow the on-screen instructions to properly obtain a Cub Foods account to complete and submit an online entry.

One (1) entry per person, per day regardless of entry method. The Sponsor and Administrator are not responsible for incomplete, lost, late, mis-directed, or illegible entries, or for failure to receive entries due to transmission failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with sender or Sponsor.
